FIELD DAY - 79

I personally would like to thank W8TK and his wife for their hospitality during Field Day-79. Not only did Tom and Laura provide a location, they opened their house to a pre-field day party. This made for a nice first MRRC Field Day. Thanks also to all who helped and participated.

The club successfully operated two entries from W8TK's farm near Delaware, Ohio. K8MR/8 ran class 2A for 2025 QSOS; from the other side of the corn field, about a thousand feet away, W8TK/8 in 1A came through with 1190 QS. Comparing the results to last year's scores, the MR score would have been fourth in 2A, and the TK score eight in 1A, among those running generator power.

Since I naturally was expecting to take first in both classes, here are the areas I see for improvement. We ran a bit short on set up time. The rigs, antennas, and tents were already in time, but more time would have permitted operators to become familiar with the equipment before the contest. Too much time was spent on bands that were worked out or otherwise not the best band to be on, often because the operator was not sure of how to tune the rig and understandably did not want to fry someone else's rig. The Drake lines were at times not used to their

maximum capabilities due to folks not being familiar with all their versatility. Likewise more time would have permitted checking out cross station interference ahead of time, which caused problems when the stations tried 80 cw and 75 ssb simultaneously. The equipment and antennas worked well, though next time I'd like to see some rf speech processing on the phone rigs.

Next year? Tom Kravec's farm seemed to survive our weekend, and is available for next year. K3LR says it may be possible for Mad River to use the magic WPA hilltop where LR has been operating the past few years. This year the usual 3A gave way to Tim's solo 1B effort. His results: 1504 QSOs (about 1100 cw) and the unofficial winner in the class. So now to see if there will be any gasoline around come next June.

CAC:

The CAC has not been officially deciding much, largely because chairman WING has been swamped at work and not doing much CAC business. There are a number of questions before the committee; comments are welcome on any of them.

KIKI has proposed increasing the SS time out minimum from 15 minutes to 30, in order to reduce rubber clocking. The few comments from the CAC have been against this change; with deadlines for October QST upon us, it's probably too late for comments on this.

There is a general discussion on the length and number of contests - see WIXX's comments in September QST, p.105. In particular, the question is raised about combining the CQ 160 with the ARRL 160, or dropping one or the other.

The problem remains with the multi-single ten minute rule for DX and Radiosport contests; one change being considered, proposed by NCCC, would permit an exception to the 10 minute rule to work a new multiplier only.

Other items are a two transmitter multi-multi for the DX test; dropping the "portable" designation requirement for those out of their particular call area; permitting DXpedition scores to count toward club competition in the DX test; eliminating the distinction between old and new novices in the NR; and changes in contest exchanges to get away from everything being 59/599.

Comments on any of these things should go to KIKI at ARRL HQ for xeroxing and distribution to the CAC.

DXpedition:

K8MR is currently planning for a contest trip for the CQ WW phone contest, October 27-28. Present target is VP5; an application has been sent for a license, and hotel accommodations are being pursued by a local travel agent.
