OH2BH ANNOUNCES

TWO NEW DXCC COUNTRIES

Marti Lane, OH2BH, who was instrumental in bringing us SORASD and 4JIFS has done it again! In perhaps his greatest diplomatic coup ever, OH2BH has persuaded the U.S. and Canadian governments to trade a pair of islands for the two 1988 CQ Worldwide DX Contests! The papers will soon be signed in Ottawa finalizing the agreement.

For the two contest periods (total of 96 hours), Canada will give its Christian Island to the United States. Christian Island is located to the southern (enclosed) end of Georgian Bay, completely engulfed within Canadian territory, 10-15 miles west of Penetanguishene. Ontario.

At the same time, the United States will give South Bass Island to Canada. South Bass Island is located in Lake Erie just a few miles north of Port Clinton and Lakeside, Ohio. Two other islands, North Bass and Middle Bass, are positioned between South Bass Island and the Canadian mainland. Both of these islands qualify for separate country status under DXCC regulations, although the presence of Canada's Pelee Island 10 miles northeast of South Bass Island may bring DXCC scrutiny of this one.

Major contest efforts will be mounted on both of these islands during both the Phone and CW portions of the CQ Worldwide DX Contests. On S. Bass Island the callsign will be CHILL. On Christian Island WOISME will be used. In recognition of this startling diplomatic achievement, a slight rules exception will be made. Normally, in CQ Worldwide, intercontinental QSO's provide 3 QSO points and intra-continential contacts count 1 point. All QSO's with and by these multi-multi stations from Christiand and South Bass Islands will count 3 points. This should assure that astounding contest records are set.

In addition to DXCC and CQ Worldwide credit, these operations will interest prefix chasers. The governments of Canada and the United States have proclaimed that the CH1 and WO1 prefixes will be retired following these contests.

This is not a cosmetic diplomatic agreement. At the start and end of each 48-hour period, formal flag ceremonies will be held. Canadian fishing boats will swarm around South Bass Island to exercise fishing rights in "Canadian" territorial waters. Americans, prohibited from buying Ontario waterfront properties for many years, will storm Christian Island attempting the largest land acquisition since the purchase of Alaska!

This activity promises to provide excitement for many people, including DXers, this fall. The DX Advisory Committee will weigh carefully the questions raised. There are infinite island trades which could be worked out around the world. Japan and the U.S.A. alone could make a number of swaps in the western Pacific. DXCC-500 might not be impossible to achieve.

A member that attends at least 2 meetings in the preceeding 12 months. That makes sense to me.

As "Big Fish", I recommend that we establish membership eligibility as " a dues paying member that has attended a minimum of 2 meetings in the previous 12 months prior to the contest of which they are participating in". Since I have never seen the club by-laws, this will be discussed and voted on at Findley.

CAC action has been slow in 1988, but we are finally beginning to work up some discussion on a few new topics. In order to represent the views of Great Lakes Division contesters, I need input on these matters. Please help all of us by indicating your opinions on the topics listed in the mini-survey below. Feel free to comment at length as you feel appropriate on these or any other items you would like to bring to the attention of the CAC. I would appreciate hearing from you either on the Monday night net or at the Findlay meeting as well. Please remember the quality of the CAC's work can only be as good as the quality of the input we receive from the contest community. That's YOU!

CAC MINI-SURVEY

- 1. Single operators who are connected by a spotting net of some kind in the DX Test are currently classified as multi-single entries.
- 1(a). Should such entrants be exempt from the rule mandating a minimum time on each band of ten minutes?
- 1(b). Should such entrants constitute a distinct and separate class?
- 2. Should the 160 Meter Contest rules continue to mandate the 1830-1850 "DX window"?
- 3. Should the current VHF and UHF contests be restructured into separate contests for VHF (220 MHz and below), UHF (432 to 902 MHz) and microwave (902 MHz and above)?
- 4. Should the present DX Contest exchange be changed to something more meaningful such as serial number or ITU zone? Suggestions?
- 5. Current ARRL club competition rules require that at least 66% of the operators in a multioperator effort be club members if the score is to count for the club competition. It has been observed that this tends to discourage the introduction of novices or other noncontesters to the sport by way of participation in multioperator efforts. Should this rule be eliminated or modified? Any suggestions?

MICHIGAN REPORT - By Dave Pruett, K8CC

Not much has been happening up in this part of Mad River country recently, probably due to the awfully hot WX which saps one's enthusiasm for outside antenna projects. Now we know how it is in Southern Texas! Anyways, perhaps now the extreme heat will subside and we can get down to business.

K8CC spent a week back in mid-July on a vehicle evaluation road trip for his employer (Chrysler). While on his way thru the sunny south, he managed to stop in Houston for dinner with Dave, K5GN and wife Amy, plus Dale, KG5U. The after dinner attraction was a trip out to superstation NR5M, hosted by Chuck, K5LZO, and Ken, KE5IV. NR5M is really something, with NINETEEN towers in the air. I got to see my first real life 80m beam (a 2L Telrex up 140') and the beginnings of the 280' tower which will hold the 3L/3L 80m stack (KLMs)!!! Unreal...

On a little more realistic note, two days further down the road I found myself in Nashville, Tennessee. Not 300 yards from the parking lot of my hotel was a Rohn 45G tower, KT34XA and 402CD. A phone call later confirmed my suspicions that the installation was that of well known contester N4ZZ. Don picked me up from the hotel and drove me back to his QTH, where we spent two hours in serious contest BS'ng. Inside, he has a TS930s and a B&W PT2500A amplifier. A very neat station which historically has done well in stateside contests.

WATCH YOUR STEP DEPARTMENT - Two days before the Pennsylvania MRRC meeting in August, our very own "BIG FISH", Mr. N8CXX, managed to survive a nasty fall from the roof of his house while adjusting the gamma match on a 10m beam. It seems that an errant screwdriver leaped out under John's foot while he wasn't looking, causing him to lose his balance. Fortunately, he was able to tumble onto the lawn (rather than the sidewalk), preventing a serious injury from being much worse. None of this prevented Mr. Tymensky from making the trip to PA for the MRRC meeting, thanks to an able chauffeur (K8JM) and an ample supply of prescription painkillers.

Speaking of the Pennsylvania meeting, Michigan was amply represented by the likes of K8AQM and K8CC, in addition to K8JM and N8CXX. In fact, the party was well into Happy Hour before the Ohio contingent outnumbered us Michiganders! Nonetheless, there was a good turnout for the meeting and I am here to say publically that K3TUP knows how to throw a party. I heard more than one person comment that "we wont miss this one again...". Thanks a meg, Mr. Kanzius, from the entire Michigan contingent.

The big MRRC aluminum order arrived in mid-August. Some is slated to go into storage, and some implemented quickly, but almost all will ultimately contribute to the MRRC effort. Along those lines, several MRRC Michigan stations have improvements planned:

- N8CXX Adds a second 5L 15m for stack, rework the 10m stuff into 5L/5L. Also a new Cushcraft 402CD on 40m.
- W8UA Big project is a Telrex rotator for the 40m & high 20m beams. Also requires repair on 80m phased verticals. Has aluminum for 2nd 6L 10m.
- K8CC Big high-band improvements planned. Second 5L 15m will make a stack. 10m will see 6L @ 130', 5L/5L @ 80'/40' for EU and 3L @ 60' on SA. Still seeking invincable cannon for 80m.

All this antenna work to do, and we are coming down to the wire. By the time this is in print, CQWW SSB will be only eight weeks away!

Not too many new packet developments this month. The K8CC Mini-BBS has been proving useful in the metro area, but has recently been victim to power outages and software bugs. The new antenna/tower at W8CAR in Sandusky has dramatically improved the path down into Ohio, although recently it has not been necessary with the K8AZ PacketCluster often mid-scale. K8AQM is very close to being QRV on packet from Adrian. Ted reports that he has 11L@70' aimed at K8CC, and 11L@80' aimed at N8ET near Findlay. Once the PK-64 is connected to the 2m rig, 'AQM might be the link we need between Findlay and Detroit.

What is everybody doing for the fall contests? K8CC will be multi-single in CQWW SSB and SS SSB, and single op for the CW versions of these same events. N8CXX reports multi-ops for CQWW SSB and SS SSB. W8UA is targeting CQWW CW single op all band. Drop me a line and let me know your plans. No promises, but I might be able to help with antenna work, or connect operators with empty operating chairs. We have a lot of good people and stations, we just need to get them on the air!

At the Michigan MRRC meeting, the club discussed ways to dress up the club Hospitality Suite at Dayton. Experience has shown that these pictures should be no smaller than 5X7 to be placed on a wall. Of course, bigger is better, but also more expensive. One large photo, or a collection of smaller photos, mounted in a frame, would be very effective.

Most photo labs (but not the one hour places, typically) can do this kind of enlargement. Color is preferred (and more available), but black and white is possible. 35mm negatives make the best enlargements.

PACKETCLUSTER MEETS MAD RIVER

No this isn't a movie review of the latest horror flick out of Hollywood, but rather a brief report on recent PACKET activity among MRRC folks in the Cleveland area.

Packetcluster came to Mad River country for the first time this summer. Starting in mid-July, K8AZ has been running the AK1A Packetcluster system on 144.95 from Chesterland, east of Cleveland. Response has been enthusiastic, with nightly use of the system by six stations.

Currently; Packetcluster at K8AZ is running on a PC XT clone with a 20 MEG hard-drive. The RF end of things is being handled by an IC-28A driving a Mirage brick to 150 watts output. The antennas being used are a 16 element collinear vertical at 80 ft. and an 11 element yagi at 100 ft, pointed at K3TUP.

Packetcluster has many features that are of interest to contesters(and DXers too). A station connected to the system can send or receive DX spotting announcements; talk to any other individual station connected to the main node(KBAZ); enter a conference with all connected stations; receive sunset/sunrise, beam heading, MUF and WWV information stored in the computer's data base; and examine the data base of DX spotting announcements by band or prefix.

Current plans are to utilize Packetcluster during the fall COWW contests for multplier sharing and to also increase interest in casual DXing during non-contesting periods. If you have packet capabilities and can connect to KBAZ(from the west digi through WBCAR and KBMR or from the east K3TUP or K3LR), join the fun!

A map is included in the FLASH, and I will be listening on the Findlay repeater (147.15/75) along with 146.52. It's the only antenna farm in Mt.Cory.
